Agenda Item No. 90-02/2023:

Action taken on the decision of 89th meeting of Board of

Governors held on 30/05/2023

Approved. The Board took the following decisions while discussing the Action Taken Report.

- 1. In decision No.89-05c/2023, the Board decided to sent a letter to Institute of Public Auditors of India (an agency run by retired auditors) to discuss about all the issues regarding Income Tax penalty, GST etc.
- 2. In decision No.89-11/2023, the Board authorized the Principal to examine whether implementation of 7<sup>th</sup> AICTE pay scale is a mandatory requirement to apply for NBA Accreditation/AICTE affiliation.
- 3. In decision No.89-12/2023, the Board entrusted the Principal to take necessary steps to commence an industry oriented inter disciplinary M.Tech. Course instead of M.Tech. Course in Machine Design.
- 4. In decision No.89-16/2023, the Board discussed the matter of staff members deputed for Ph.D under QIP not acquiring the Ph.D degree many years after the deputation period. The Board expressed displeasure in the matter and directed the Principal to issue notice to recover the amount as per the bond conditions.
- 5. In decision No.89-30/2023, the board decided to request KSRTC to start bus service in the route specified by the College subject to the condition that the College should ensure minimum 40 passengers from SCTCE.

Agenda Item No.90-03/2023: Report of the Principal

The Board is pleased to note the increased percentage of B.Tech. first year admission during 2023 - 2024. The Board noted that the graduation ceremony was conducted for the first time in the history of the College and expressed extreme pleasure and congratulated the Principal and entire team of staff members for successfully conducting the glorious event.

The Board noted the results of various semesters and overall position at the University level. Members of the Board opined that the present position (14) needs to be improved. The Board noted with pleasure that excellent result in B.Tech.Computer Science & Engineering, Mechanical (Automobile) Engineering and Artificial Intelligence & Machine Learning branches in eighth semester examinations. The Board also noted the low pass percentage in Mechanical Engineering, Mechanical (Automobile) Engineering, Electronics & Communication Engineering and Artificial Intelligence & Machine Learning branches in lower semesters.

Principal assured that earnest efforts like remedial classes will be organized to improve the pass percentage. Principal also assured the Board that the overall position of SCTCE will be brought to less than 10 with these efforts.

The Board appreciated the team of SCTCE for the successful conduct of "training and awareness programme to Ambulance drivers and School bus drivers on Road safety" and appreciated the efforts of the coordinators Dr.Arun.M and Dr.Sreejith. B J.

The Board directed the Principal to give more thrust to increase the sports facilities of the College.

The Board also accorded sanction to start an additional batch of Computer Science & Engineering branch with an intake of 60 students w.e.f. 2024-25.

The Board entrusted the Principal to take necessary steps to commence an industry oriented inter disciplinary M.Tech. Course instead of M.Tech. Course in Machine Design. Financial viability of the newly proposed courses need to be ascertained and analysed before finalizing the courses
